ESSAY: THE FUTURE OF ONLINE LAW REPORTING IN NIGERIA CHIDINMA OJIGWE

In Nigeria, legal research and practice has in the recent past experienced a major breakthrough, orchestrated significantly by the rise of online law reporting. There is no gainsaying the fact that the future is bright as can be foreseen in the following ways:

1. Increased Accessibility and Inclusivity

2. Integration of Advanced Technologies

A CONVERSATION WITH OLUWOLE KEHINDE

As a user of online law reports and editor of the biggest law reporting firm in Africa can you describe the current state of online legal reporting in Nigeria?
